Rental payments will be made to the Williams SWCD at the address shown above within 30 days of the invoice. **Terms of the invoice are as follows: Net 60 days from Date of Billing. A service Charge of 1 1/2% per month (18% per year) assessed from the Date of Billing for all accounts over 60 days past due.** All equipment bills must be paid in full before renter may use any of the District's equipment. If full or partial payment is not received within 9 months, it will be turned over to the Williams County Prosecuting Attorney for collection. The SWCD reserves the right to determine the order of servicing the above named renter. The equipment must be used in a careful and prudent manner. Equipment must be returned in as good of condition that it was received, reasonable wear and tear, and defects in materials or workmanship excepted. If upon its return to the District the equipment is not in such good condition, the District may repair it and the above named renter will pay the cost of any such repairs at regular shop rate. The above named renter assumes all risk and liability for and will hold the Williams SWCD harmless from all damages for injuries or death to persons and property arising out of the use, possession or transportation of the equipment. The above named renter will possess adequate farm liability insurance for the public or personal liability and property damage during the period of the possession of said equipment.
